#### **Employment**

Within employment — just one aspect of the reentry experience — federal job training programs are disjointed, often inaccessible to returning citizens, and are ineffective in helping a diverse group of job-seekers move toward mobility:

Limiting Investment in Small Providers



#### **Covered Program**

A Federal Government program that makes

investments in one or more of the following seven areas:

- · Climate change
- Clean energy and energy efficiency
- Clean transportation
- Affordable and sustainable housing
- Training and workforce development
- Remediation and reduction of legacy pollution
- Critical clean water and waste infrastructure


#### **Covered Investment**

A Federal investment in one or more of the following categories:

- Federal grant and procurement spending (including discretionary budget authority, direct/mandatory spending, and formula funding);
- Financing (including credit, loans, and guarantees);
- Programmatic Federal staffing costs (e.g. federal pay for staff that provide technical assistance)
- Direct financial benefits (including provision of goods and services); and
- Additional federal investments under covered programs as determined by OMB.

tracts)


15,172 census tracts as disadvantaged (~20% of 74,170 total U.S. census tracts)

#### **Community Benefits Plans**

- All projects funded by BIL & IRA will require a Community Benefits Plan (CBP).
- CBPs are based on a set of four core policy priorities:
  - Investing in America's workforce;
  - Engaging communities and labor;
  - Advancing diversity, equity, inclusion, and accessibility;
  - Implementing Justice40.
- CBPs will be part of the contractual obligation of the funding recipients and will be publicly posted on DOE's website.





### Formula vs. Discretionary Grants

Formula – statutorily defined and funded annually through congressional appropriations processes

▶ Discretionary – Funding Opportunity Announcements or FOA's (can be competitive or non-competitive, cooperatives, etc.)

#### **Grants vs. Prizes**

- Amounts of awards and volume of opportunities differ between grants and prizes
- Extended grant allotment timetables based on past experiences and ongoing performance vs single application
- Well known "Monitoring and Evaluation" processes for grants are virtually unknown for prizes
- More technical and process driven than prizes
- Prizes are sometimes a combination of public and private funds

#### **Grants vs. Prizes**

- Grants are far less centralized you can find most of them on https://www.grants.gov/search-results-detail/352897 or departmental funding opportunity announcements pages (i.e., DOJ).
- DOE grants are program office specific, and therefore far less centralized
- Prizes are more centrally located (i.e.

#### Upskill Prize for the Solar Manufacturing Workforce



#### **Timeline**



Who can participate > Open to a private entity, non-profit, non-federal government organization, or academic institution. The prize **requires** partnerships between U.S. manufacturers and training organizations, aiming to attract new individuals to careers in solar manufacturing with job-ready training programs.

**Prize Amount>** \$5 million in cash prizes is available for winners of the Upskill Prize. Individual team awards will be up to \$500,000, depending on the work proposed.

#### What you need to know

Competing teams propose comprehensive workforce training plans that are composed of either or both:

New Worker Training: Develop and propose plans to train new workers with the skills they need to be successful in the solar manufacturing industry, particularly at new or expanding manufacturing facilities.

Incumbent Worker Training: Develop and propose plans to train incumbent workers with new skills needed to support the growth of solar

## Electronics Scrap Recycling Advancement Prize

The Electronics Scrap Recycling Advancement Prize (E-SCRAP) is a \$3.95M challenge sponsored by the U.S. Department of Energy's (DOE) Advanced Materials and Manufacturing Technologies Office (AMMTO). The prize aims to stimulate innovative approaches that reduce the costs and environmental impact of critical material recovery from electronic scrap (e-scrap).

Prize is **Open** 

Total Prize Pool: \$3,950,000

Submissions due: September 4, 2024 at 3:00 pm MDT



#### **INCUBATE**

- · Up to 10 winners
- · \$50,000 cash prize per winner
- Up to \$30,000 in analysis consulting

#### **PROTOTYPE**

- Up to 5 winners
- · \$150,000 cash prize per winner
- Up to \$120,000 in analysis technical support

#### DEMONSTRATE

- · Up to 3 winners
- \$600,000 cash prize per winner




#### Workforce Development and Careers in Energy

- Formerly incarcerated compose only 1% of the energy workforce, compared with 2% of the total workforce

#### What is a Sub-Contractor?

A subcontractor is engaged by the Prime Contractor and has no "direct" privity with the government. Their relationship is strictly with the Prime Contractor. The subcontractor is paid by the Prime Contractor.


## Department of Energy- Example - E. O. 14008
